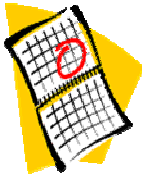

Mandatory Reporters and the Abuse Hotline

More than 1 million children are victims of child abuse and neglect each year. Many victims do not receive help because they are not reported to the system. Chapter 39 of the Florida Statutes mandates that any person who knows, or has reasonable cause to suspect, that a child is abused, neglected, or abandoned by a parent, legal custodian, caregiver, or other person responsible for the child's welfare shall immediately report such knowledge or suspicion to the Florida Abuse Hotline. Day care workers are among many Mandatory Reporters. If you suspect that a child has been abused, abandoned, neglected, or exploited, contact the Abuse Hotline at **1-800-96-ABUSE**. Please remember to submit the Informed Parental Consent for Delayed Enrollment Form for any children that did not physically attend on the first day of your program. Important Due Date

Did your VPKS program end in August? Is so remember your Provider Verification Report (PVR) is due on or before September 30th!!! If ECS does not receive your PVR by this date then we will be withholding your final VPKS payment, no exceptions.

(These reports are sent out to by the VPK Department once your August attendance rosters have been processed).

To ensure full compliance with OEL policy ALL final VPK payments will be actual checks, even if you normally receive direct deposit.
